

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

Assumption of Risk: The novel coronavirus/COVID-19 has been declared a worldwide pandemic by the World Health Organization. It is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people, to help slow the spread of the disease.

Allegro Community School of the Arts has instituted measures in an attempt to prevent the spread of COVID-19. However, Allegro cannot, and expressly does not guarantee the students will not become infected with COVID-19 as a result of receiving instruction in person. Furthermore, given the nature of the instruction, close contact between students and teachers, and even other students, cannot be avoided.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending classes at Allegro and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at Allegro may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Allegro staff, instructors, members of the Board of Directors, volunteers, other students and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to personal injury, disability, and death), illness, damage, loss, claim, liability, or expense of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at Allegro or participating in Allegro programs (Claims). On my behalf, and on behalf of my children, heirs, estate, personal representatives, and successors, I hereby release, covenant not to sue, discharge, and hold harmless Allegro, its staff, instructors, volunteers, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Allegro, members of the Board of Directors, staff, instructors, volunteers, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Allegro classes or programs.

Conduct: Student(s) and family members understand and agree that they must follow all lawful instruction or direction from Allegro and its teachers, instructors, volunteers, and staff while receiving instruction and that failure to do so may result in Student being ask to leave the Allegro premises.
